If you have specific concerns or restrictions regarding the display of your project, please communicate this to us in writing during the project briefing or prior to project completion. We value transparency and aim to create a collaborative and respectful working relationship with our clients.
<b>GST</b>	One Mimosa Please offers a formal quote without the inclusion of the GST component. Once the quote is accepted, we will add the GST component.
<b>Design Revisions</b>	Revisions, particularly those requiring sketching, hand-lettering, and intricate details, might extend the timeline for design revisions or overall completion.
<b>Payment Date and Design Date</b>	<p>Your design will be scheduled according to the date of payment. Once we receive your payment, we will accommodate you in our calendar to the best of our ability.</p> <p>Quotations remain valid for a period of 7 days. If, within this timeframe, the quote is not accepted, our availability might not be assured.</p>
<b>Lead Time</b>	A lead time of up to 12 weeks before your event is recommended. Expedited services incur a rush fee of \$175.
<b>Order Deadline</b>	Orders are not accepted within 6 weeks of the event unless a mutual agreement has been reached.
<b>Printing Service</b>	<p>Our reliance on a third-party printing service dictates our timeline. Should time constraints and extensive client revisions pose a risk to the printing timeline, a warning will be issued.</p> <p>In the unlikely event that a printing warning has been issued, One Mimosa Please disclaims responsibility for any third-party delays, and no refund will be provided for any delayed stationery elements that do not arrive in time.</p>
<b>Revisions and Additional Design Fee</b>	<p>We allocate time for each couple to ensure an effective scheduling system. Consequently, 4 revisions for each stationery element are provided.</p> <p>Beyond the stipulated revisions, an additional design fee of \$75.00 applies. This policy is designed to cover capacity and prevent revisions from affecting another client's design or schedule.</p>

We do not offer a refund for change of mind or change of quantity.

**Refund Policy**

- In the event the design process has begun:
- 1 proof provided: 75% refund (minus the bespoke design fee)
  - 2 rounds of revisions: 50% refund (minus the bespoke design fee)
  - 3 rounds of revisions: 25% refund (minus the bespoke design fee)
  - We do not offer a refund for a change of mind or change of quantity.
